We invite you to publish your scientific papers in the Proceedings of the International Scientific and Practical Conference "Biological Safety under Global Threats: Scientific and Technological Approaches to Counteraction", which will be held on November 27-28, 2025 in Astana, the Republic of Kazakhstan.

The proceedings of the conference are a unique publication in terms of their information richness and relevance for specialists in the field of biosafety, molecular diagnostics and molecular biological research, healthcare, epidemiology, veterinary medicine, microbiology, pharmaceuticals and related industries.

The collection will be assigned an international ISBN number.

**The deadline for submitting abstracts is November 15, 2025!**

**Rules for the registration of works:**

The works must be typed in a Word text editor and carefully edited, as they will not be edited in the future.

Abstract design languages: Kazakh, Russian, English.

Font – TimesNewRoman, font size 12 with 1 interval. Margin size: left – 30 mm, right – 15 mm, top – 20 mm, bottom – 20 mm, paragraph indentation – 10 mm. The maximum volume is 2 pages. Text alignment: width-wise.

In the upper-left corner of the abstracts, you must specify the UDC (without italics, in straight font).

The title should be printed in CAPITAL LETTERS, aligned in the middle, in bold.

The names and initials of the authors are printed in capital and lowercase letters. The name of the author presenting the report at the conference is underlined, the line with the names of the authors is given 1 interval apart from the title.

The next line indicates the name of the institution, city, and country.

Keywords (3-5 words or phrases) (see sample). The title of the report should not exceed 25 words. The text of the theses is no more than 400 words.

The works should contain specific factual scientific material obtained personally by the authors and consist of the following sections: introduction, purpose and objectives, materials and methods, main results, conclusion/conclusions. The content of the abstracts must necessarily reflect the relevance and significance of the research, the novelty of the data obtained and their applied significance.

It is allowed to include illustrations and tables if they are critical for understanding the presented results.

Abstracts must be original and free of plagiarism.

Advertising information is not allowed in the works.
